

OFFICIAL RULES
Golf Town's Ladies Night Out RSVP Draw

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

General. Golf Town's Ladies Night Out RSVP Draw ("Contest") is sponsored by Golf Town Limited, 7777 Weston Road, Suite 900, Woodbridge, ON L4L 0G9 ("**Sponsor**"). The Contest is subject to these official rules ("Official Rules") and to all applicable federal, provincial and municipal laws.

2. Eligibility. To enter and be eligible to win, a person must be a resident of Canada and have reached the age of majority in his/her province/territory of residence at the time of Contest entry (each, an "**Entrant**"). The Contest is void where prohibited by law. The Contest is open to Entrants who have registered for Golf Town's Ladies Night Out Event (the "**Event**"). Employees, representatives and agents of Sponsor, any entities or organizations involved in the Contest, and each of their respective affiliated companies, and contest suppliers, as well as immediate family members of any such person (regardless of where they live) or those with whom any such persons are domiciled are not eligible to enter this Contest. Entries are limited to individuals only; commercial enterprises and business entities are not eligible to enter the Contest. In the event that Sponsor receives more than one (1) entry per valid email address during the Entry Period, Sponsor will void and destroy duplicate entries and that entrant will be disqualified from the Contest.

3. Entry Period. The entry period ("**Entry Period**") begins at approximately 7:00 a.m. Eastern Time ("ET") on Monday April 13, 2026 and will end on Thursday April 30, 2026 at 11:59 p.m. ET.

4. Method of Entry. No purchase necessary. To enter, each Entrant must register for the Event, including completing all required information, at <https://cloud.email.golftown.com/ladiesnight2026EN>. Limit one (1) entry per Entrant. If the identity of an Entrant is disputed, the authorized account holder of the e-mail address submitted at the time of entry will be deemed to be the Entrant. The individual assigned to the e-mail address for the domain associated with the submitted e-mail address is considered the authorized account holder. A selected Entrant may be required to provide proof that he/she is the authorized account holder of the e-mail address associated with the selected entry. All entries must be submitted from a valid e-mail account that, where feasible and permitted by applicable law, may be identified by reverse domain name search. The sole determinant of time for the purposes of receipt of a valid entry in this Contest will be the Contest server machine(s). The Sponsor reserves the right, in its sole discretion, to disqualify any individual found: (i) to be tampering with the entry process or the operation of the Contest; (ii) to be acting in violation of the Official Rules; (iii) to be acting in an un-sportsmanlike or disruptive manner; or (iv) to be engaging in any other offensive conduct that jeopardizes the integrity and/or administration of the Contest, which shall be determined at the Sponsor's sole discretion. NOTE: The Sponsor will have one French and one English version of the entry form. To enter, you must only submit one entry. Submitting your entry using both versions will be considered a duplicate entry, and one will be voided.

5. Prizes and Odds. There is one (1) prize available to be won, consisting of one (1) Wilson Women's Aurora 10-Piece Cart Bag Package Set with Graphite Shafts (the "**Prize**"). Approximate retail value is \$1,799.99 CAD. Odds of winning depend on the number of eligible entries received during the Entry Period. Prize must be accepted as awarded and has no cash surrender value. Prize is awarded "AS IS" without warranty of any kind. The Sponsor may substitute a prize of equal or greater value for any reason. None of the Released Parties makes any representation or warranty regarding the Prize. By accepting the Prize, winner waives all recourse against the Released Parties if the Prize is unsatisfactory.

6. Winner Selection and Notification. One (1) entry will be selected by a random drawing from all eligible entries received. The drawing will be conducted by Sponsor or Sponsor's representative at approximately 12:00 p.m. ET on Monday, May 4, 2026 at the Sponsor's office. The selected Entrant will be notified by email. If the selected Entrant cannot be contacted within five (5) business days of the first notification attempt, or if contacted, does not claim the Prize, or does not meet all the Contest conditions outlined in these Official Rules, the selected Entrant will be disqualified and an alternate Entrant may be randomly drawn from the remaining eligible entries.

NO ONE IS A WINNER UNLESS AND UNTIL THE SPONSOR OFFICIALLY CONFIRMS THEM AS A WINNER IN ACCORDANCE WITH THESE RULES. To be declared a winner, a selected Entrant must (i) correctly answer, without assistance of any kind, whether mechanical or otherwise, a time-limited mathematical skill-testing question administered by Sponsor; (ii) sign and return a declaration and release form within five (5) business days of being notified; and (iii) comply with these Official Rules.

7. Technical Issues and Disqualification. All entries that are incomplete, illegible, damaged, irregular, submitted through illicit means, or do not conform to these Official Rules may be disqualified. All Contest-related information becomes the property of the Sponsor.

The Released Parties are not liable for: (i) any failure of websites, platforms, or systems during the Contest; (ii) tampering, fraud, technical or mechanical malfunctions; (iii) failure of entries or notifications to be received or recorded; (iv) injury or damage to any person's computer or device; (v) anyone being incorrectly identified as a winner; or (vi) any combination of the above.

The Sponsor may disqualify any Entrant who: (i) attempts to obtain more than the permitted entries using multiple identities, email addresses, or automated methods; (ii) tampers with or undermines the Contest operation; or (iii) violates the letter or spirit of these Official Rules. ANYONE DEEMED BY THE SPONSOR TO BE IN VIOLATION OF THESE RULES IS SUBJECT TO DISQUALIFICATION AT ANY TIME.

8. Privacy. The Sponsor is collecting personal data about Entrants for the purpose of administering this Contest and, if an Entrant should so elect at the time of entry, to communicate with Entrants about the Sponsor's products/services/offers. Consenting to receive such communications is optional, is not required in order to be eligible to enter this Contest and does not improve chances of winning any Prize. Entrants not wishing to receive any other informational or marketing communications from the Sponsor should so indicate when they enter the Contest, and are free to opt out of receiving any such communications at any time.

By entering this Contest, each Entrant expressly consents to the Sponsor, its agents and/or representatives, storing, sharing and using the personal information submitted only for the purpose of administering the Contest and in accordance with the Sponsor's privacy policy. This section does not limit any other consent(s) that an individual may provide the Sponsor or others in relation to the collection, use and/or disclosure of their personal information. Please see the Sponsor's Privacy Policy at <https://www.golftown.com/en-CA/privacy-policy.html> for information on the Sponsor's policies related to the collection, use and safeguarding of personal data.

By entering this Contest, each Entrant acknowledges that if they win, their surname and country of residence may be disclosed to persons enquiring, where permitted by law. Any Entrant may object to their information being made available in this way, or may request that the amount of information made available be reduced, by contacting the Sponsor using the contact details at the end of these Official Rules.

9. Publicity. By accepting a Prize, each winner agrees that the Sponsor and its respective designees may use their name, photographs, videos, likeness, city of residence, biographical information, prize information and/or statements about this Contest, Prize, or Prize-related activities for advertising and/or publicity purposes in any and all media (now or hereafter known) throughout the world, in perpetuity without compensation, notification, or permission, unless otherwise prohibited by law.

10. Release and Liability. By participating in the Contest, each Entrant forever releases, indemnifies, defends, and holds harmless the Sponsor, its advertising and promotion agencies, and prize suppliers, their affiliates and respective directors, officers, owners, partners, employees, agents, dealers, representatives, successors and assigns (the "**Released Parties**") from any and all liabilities, losses, damages, rights, claims, and actions of any kind in connection with the Contest, including any and all damages, injuries, death, loss or liability to person or property, due in whole or in part, directly or indirectly, by reason of entering the Contest, the acceptance, possession, use or misuse of any prize, or while preparing for and/or participating in any Contest and/or Prize-related activity, and their participation therein and to indemnify the Released Parties against any and all claims, damages, liabilities, costs, and expenses arising from their participation in the Contest. By participating in this Contest, each Entrant also agrees that their participation complies with all conditions stated in these Official Rules. The Released Parties will bear no liability whatsoever regarding: (i) the use of any entry or Contest-related information; (ii) participation in any Contest-related activities; (iii) any use, collection, storage and disclosure of any personal information; and/or (iv) the Prize (including any use or misuse of the Prize). The Released Parties shall be held harmless by the Entrant in the event it is discovered that an Entrant has departed from or not otherwise fully complied with any of these Official Rules. This release and indemnity shall continue in force following the termination of the Contest and/or awarding of any Prize.

By participating in this Contest, each Entrant agrees to abide by and be bound by these Official Rules, and to waive any right to claim any ambiguity or error herein or in the Contest itself, and to be bound by all actions of the Sponsor and/or Sponsor's representative(s), whose decisions are binding and final on all matters related to this Contest.

11. Construction. This Contest is subject to all applicable federal, provincial and municipal laws. The decisions of the Sponsor with respect to all aspects of this Contest, including without limitation the eligibility of Entrants or any Contest-related information, are final and binding on all Entrants without right of appeal.

The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules shall otherwise remain in effect and shall be construed in accordance with the terms as if the invalid or illegal provision were not contained herein.

All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of Entrants and the Sponsor in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the Province of Ontario without giving effect to its conflict of law rules and provisions. All Entrants consent to the jurisdiction and venue of the Province of Ontario. All Entrants expressly agree that the Ontario courts shall have sole jurisdiction over any dispute or litigation arising from or relating to this Contest, agree to submit to the laws of and the jurisdiction of the Federal Court of Canada and Superior Court of Justice of Ontario, as applicable, and hereby waive the jurisdiction of any other court that now or in the future could be considered competent for any reason. The venue shall only be Toronto, Ontario.
